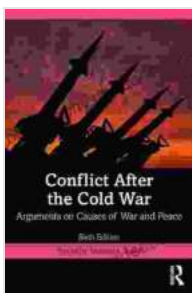

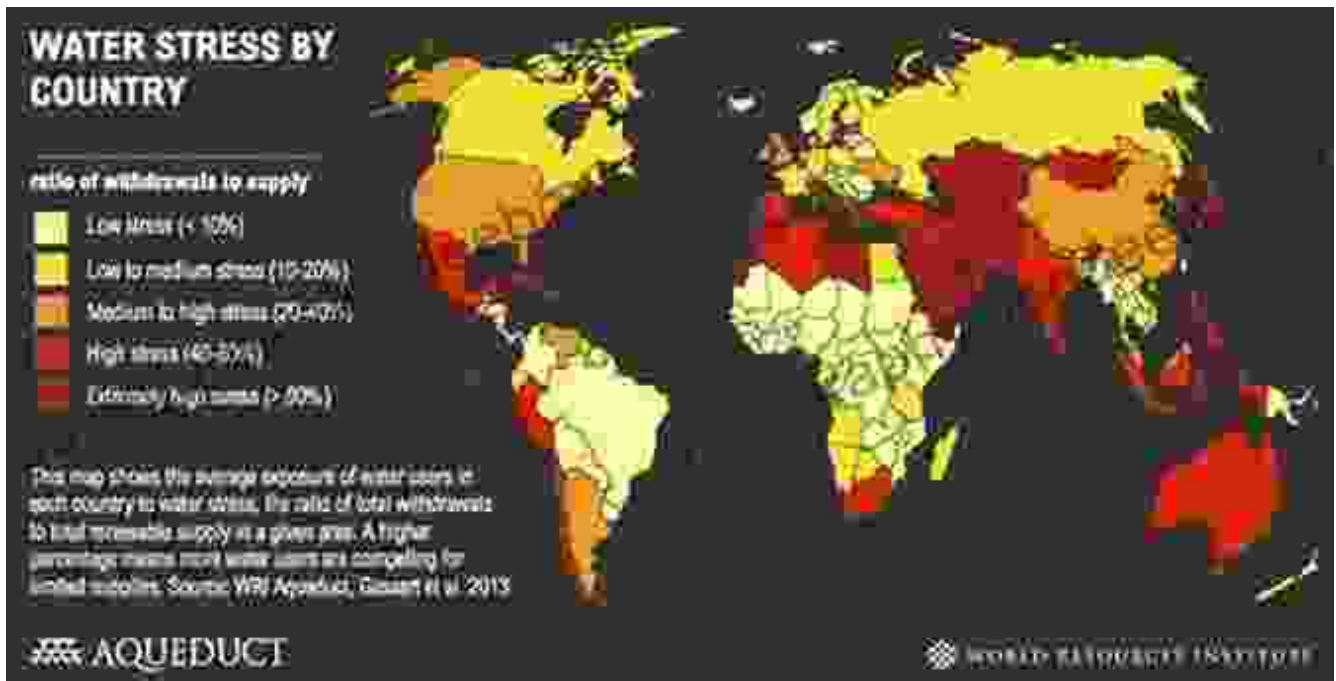
## The Psychological Perspective

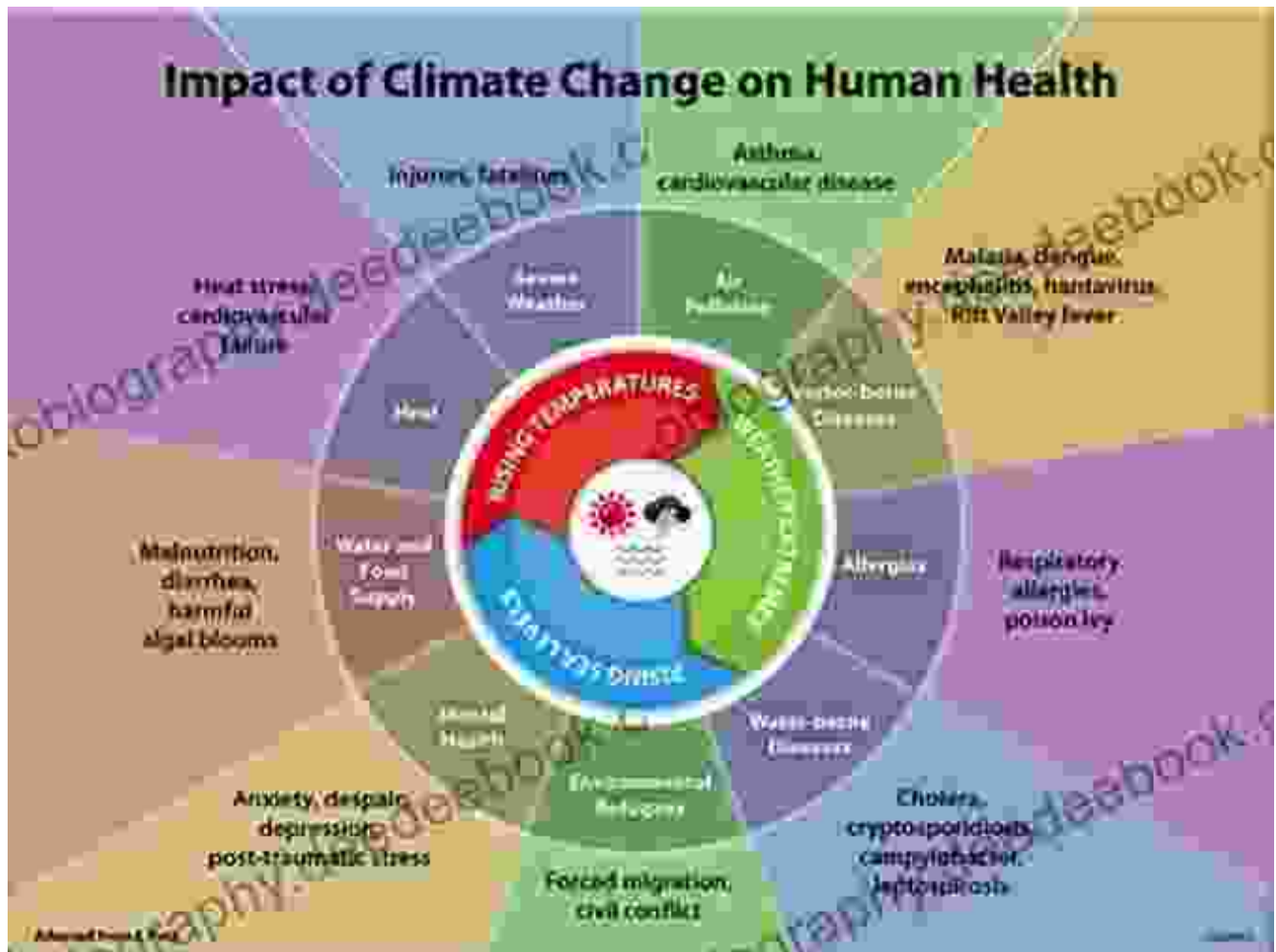

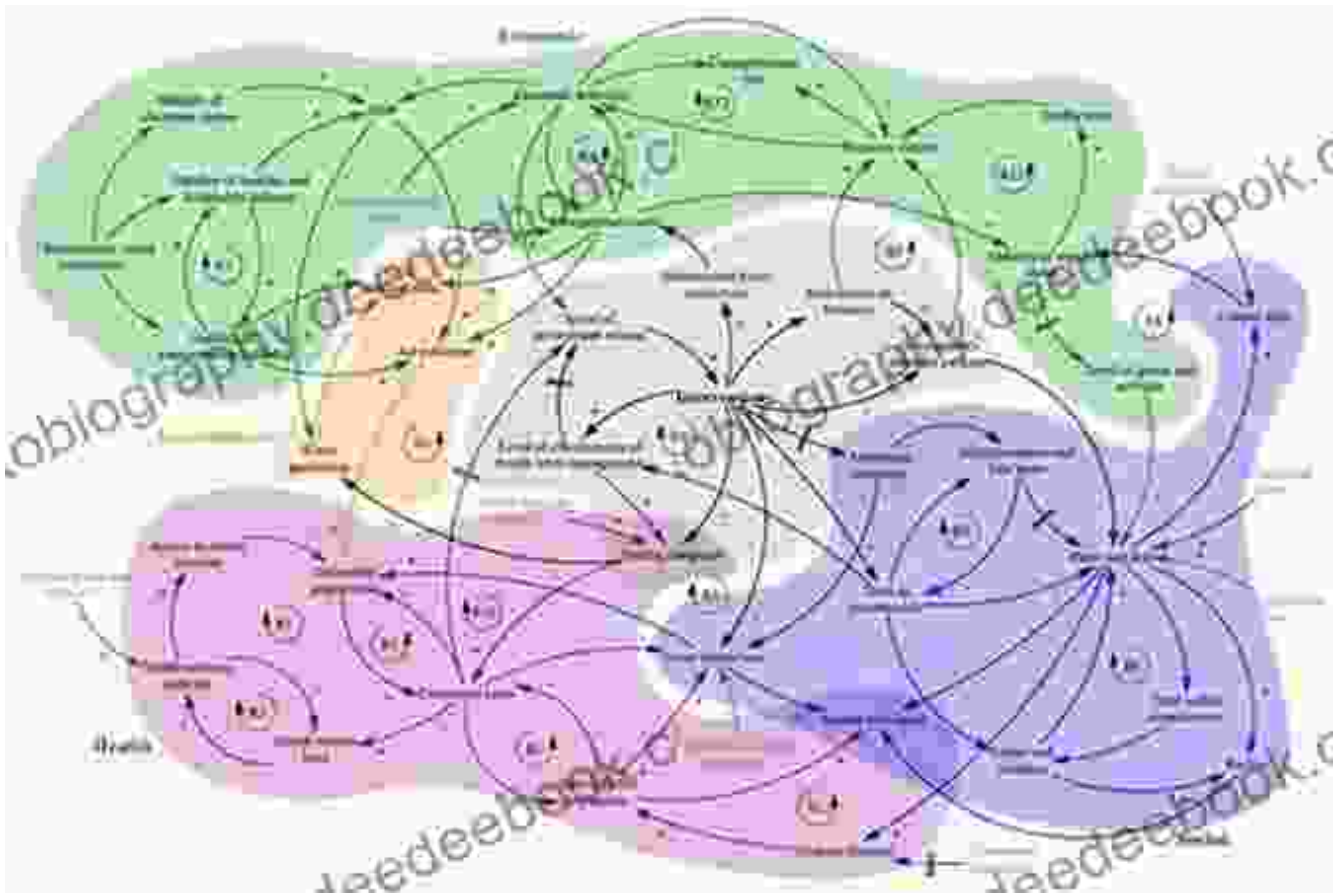
