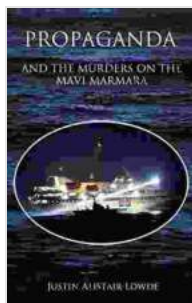


Propaganda and the Murders on the Mavi Marmara: Uncovering the Truth

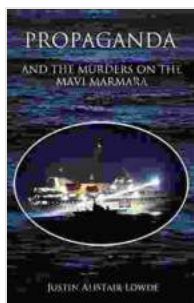
